6	<p>Give your views on the structure of the programme and sessions included:</p> <ol style="list-style-type: none"> 1. Curriculum of 2003 and 2008 should have been supplied earlier; for preparation of module of induction should have been a longer programme. 2. Study materials should have been sent earlier, so that we could gather your expectation from us about the training. Mode of training for induction level training for directly recruited district judges from Bar is also required. 3. Structure of the programme is very good and divided very wisely in different sessions. Most of major area are covered regarding induction training for newly appointed judges (Junior Division). 4. Considering the name of the programme, allocated time for sessions could have been 1.30 hours through discussion on the issues. 5. The programme has been structured well. The group discussion was very useful. 6. This time it was concise, compact and well organized programme. 7. Programme was nice and very helpful to us to work in our Academy. 8. Excellent 9. One hour sessions well and good. However, it may be extended to one hour + fifteen minutes so that the speaker shall go beyond that schedule (strictly). 10. Revisiting the curriculum from time to time is the need of the hour and this programme has been structured in a nice manner in which all the aspect that need to be revised including computerization and IT have been dealt here. However more sessions about the “How” of implementing the revised curriculum can be gone into. 11. If in advance the State Judicial Academy would have been told to come with amended or revised curricula & then after discussion of good features or all academies, if uniform curricula could have been prepared then it would have been more helpful in my opinion. 12. It was a great programme having very good speakers. 13. Excellently structured. 14. Legal experts presided over the sessions. The President, Board of Governors are taking decision with respect to curriculum of the Academy. Therefore, my opinion that the president of the respective Academy would have presided over for each sessions. 15. Designed well 16. I have learnt many things like as- How we design curriculum for our state Academy and what the correct method to teach/train them; Personality development is very necessary for every judicial officer. 4. Sharing ideas with directors from different academies was a big plus for me. 5 I have an idea now what matters are to be taken into account while preparing a curriculum. Had the opportunity to understand the best practice in our Academies. 6. Presentation made by Prof. (Dr.) Mohan Gopal particularly drawing a parallel with I.M.A. 7. I had new ideas about the methods to be adopted to give comprehensive training to the officer at entry level. 8. I have learned new ideas & have been persuaded to do new things for induction training of newly recruited civil judges (Junior Division) 9. The area of discussion which might help the newly recruited officer to be more humane.; (a) Such as making the programme of moving to the interior part of the state so as to interact with the underprivileged people; (b) making the trainees to make aware the Constitutional Vision of Justice more. 10. Listening to the officers from the other academy made we realize the short comings in my academy. Many states have a better structured and systematized induction programme and they have their own pool of resource persons from and out of their Judicial Officers which my academy lacks. So yes, a lot has to be done in my academy and this has been an eye opener. 11. I came to know about good features of curricula of induction training to civil judges (Junior Division) which may be adopted by our academy & at present used by other state academy. 12. Programme about preparation of curriculum, things to be considered for selection of resource persons, about preparation of modules, impact assessment of training programmes, Research work conducted by Judicial Academies etc. are required to be conducted at a regular interval.
